

THE CORPORATION OF THE TOWNSHIP OF HORNEPAYNE

By-Law No. 1720

**Being a By-Law to provide assistance to
Seniors for snow removal within the
Township of Hornepayne**

WHEREAS the Municipal Act 2001, S.O. 2001, Chapter 25, Section 10, provides that a single-tier municipality may pass By-Laws respecting the health, safety and well-being of persons; and,

WHEREAS the Council of the Corporation of the Township of Hornepayne deems it appropriate to offer an annual rebate of up to \$300.00 to help cover the cost of snow removal for Seniors 65 years of age and over who have paid a contractor to plow their driveways within the Municipality.


NOW THEREFORE the Corporation of the Township of Hornepayne enacts as follows:

1. That the attached Definitions, attached as Schedule "A", form an integral part of this By-Law"; and,
2. That the attached Regulations, attached as Schedule "B" form an integral part of this By-Law; and,
3. That the attached Application Rebate Form, attached as Schedule "C" forms an integral part of this By-Law; and,
4. That this By-Law may be known as the "Seniors' Snow Removal Assistance By-Law"; and,
5. That the Mayor and CAO/Clerk are hereby authorized to sign and affix the corporate seal for, and on behalf of, the Corporation to any and all documents necessary to give force and effect to this By-Law.
6. This By-Law comes into force and takes effect upon passage.

By-Law No. 616 is hereby repealed.

Read a first and second time this 6th day of March, 2019.

Read a third time and finally passed this 6th day of March, 2019.

SCHEDULE "A"
TO BY-LAW NO. 1720
SENIORS' SNOW REMOVAL ASSISTANCE
DEFINITIONS

DEFINITIONS

"Contractor" means one that contracts or is party to a contract: including one that contracts to perform work.

"Corporation" means The Corporation of the Township of Hornepayne.

"Council" means the Council of the Corporation of the Township of Hornepayne.

"Documentation" includes a government issued identification document, these documents can include: Drivers Licence, Birth Certificate, Passport, Senior's Card and Age of Majority Card.

"Municipality" means the Township of Hornepayne.

"Proof of Age" means to provide documentation to show one's date of birth.

"Rebate" means the return of a part of a payment.

"Rebate Deadline Date" means the last date documents will be accepted for this program.

"Senior" means any person aged 65 years and older. One must be 65 years of age by June 30th of the year the rebate is issued.

SCHEDULE "B"
TO BY-LAW NO. 1720
SENIORS' SNOW REMOVAL ASSISTANCE
REGULATIONS

1 REQUIREMENTS

- 1.1** To qualify for the rebate you must be a senior, aged 65 years of age or older, by the rebate deadline date.
- 1.2** The residence/address for which the application applies must be occupied by a senior who is applying for the rebate.
- 1.3** The property must be cleared by a contractor.
- 1.4** All Receipts must be provided with application form.
- 1.5** Application must include a document with proof of age. (will be photocopied).
- 1.6** All receipts must be submitted to the Township office no later than the rebate deadline date.

2 REBATE

- 2.1** Rebate amount will match receipts received up to maximum amount of \$300.00.
- 2.2** Receipts must be personalized with name and address of applicant.
- 2.3** Rebate deadline date is June 30th of the current year.
- 2.4** Rebate cheques will be issued if all required documents have been received prior to deadline date.
- 2.5** Rebate Cheque will be issued no later than July 31st.
- 2.6** Failure to provide all required documents, within the proper timelines will result in no rebate being issued.
